

# Rose Hill Community Pool Rules (2020) May 18<sup>th</sup> -Sept 13<sup>th</sup>

## DHEC Required Rules for Health and Safety

1. There should be no solo swimming.
2. There should be no running, boisterous or rough play.
3. No person under the influence of alcohol or drugs should use the pool.
4. There should be no spitting or blowing nose in pool.
5. Persons with diarrheal illness or nausea should not enter the pool.
6. Persons with skin, eye, ear or respiratory infections should not enter the pool.
7. Persons with open lesions or wounds should not enter the pool.
8. No animals or pets allowed in the pool enclosure.
9. No children 16 and younger should be in the pool without supervision.
10. You should take a shower before entering the pool.
11. **No glass allowed in the pool or on the deck.**

Due to the severity of the cost and consequences to the whole community for broken glass in the pool, there will be only one warning. A second violation will result in a \$200 fine and pool access being deactivated for the rest of the season. If a swimmer breaks glass in the pool and causes it to have to be closed, drained and cleaned, the responsible homeowner will be assessed the entire cost.

## Rose Hill Community Pool Rules

1. The pool is open from 7am or sunrise (whichever comes first) to 9pm or dark (whichever comes first).
2. **DUE TO THE COVID-19 PANDEMIC: NO GUESTS ARE ALLOWED UNTIL FURTHER NOTICE. PLEASE FOLLOW SOCIAL DISTANCING GUIDELINES.**
3. No swim lessons are permitted without Board approval.
4. No smoking in pool area.
5. No foul language, or lewd, inappropriate behavior.
6. Proper swimming attire required to enter the pool, including swim diapers when necessary.
7. No wheeled vehicle including bikes, scooters, skate boards, skates, etc. inside pool gate.
8. No loud music or music containing explicit language
9. Report trespassers to the police.
10. Do not park in handicap spot without a permit

## Key Fobs

1. Pool access is by key fob only. Only one key fob per home is permitted.
2. If you need a replacement fob, please email [pool@mycmg.com](mailto:pool@mycmg.com). The replacement cost is \$25.
3. **Key fobs are deactivated if the homeowner is more than 30 days past due on quarterly dues and owes over \$200.**
4. Homeowners with an overdue account attempting to access the pool by any other means than the key fob will receive a warning and trespass notice. Continued violations will result in fines.
5. Homeowners and families who do have access to the pool should not open the pool gate for others to access the pool.

To prevent unnecessary conflict, please report violations to [violations@mycmg.com](mailto:violations@mycmg.com) with a date and time of violation. Violation letters will be sent to the violating homeowners through Cedar Management. The third notice of a violation will result in a \$50 fine.
